**NON-REFUNDABLE FEE DISCLOSURE**

This representation is undertaken based upon your representations to us that you and your spouse have agreed on the primary matters that must be resolved during the divorce process, including but not limited to custody, visitation, child support, alimony, division of property, and payment of debts.

(1) Legal services to be performed by us, and for which you are paying according to the terms of this Contract, include and are limited to the following: negotiating the fine points of your contract with your spouse, drafting the Settlement Agreement, preparing and filing basic pleadings. We will NOT engage in discovery, interview witnesses, review or collate documentary and financial information, prepare for or participate in evidentiary proceedings, argue motions, do legal research or prepare legal memoranda or briefs, or employ experts.

(2) For the limited services described above, you will pay to us the sum of \_\_\_\_\_dollars (\$\_\_\_\_.00) as legal fees. This amount shall be paid now, is considered earned when paid and is non-refundable. You will be responsible for all court costs associated with said action. (3) You understand that this Contract is based upon the assumption and your representations to us that your divorce case will remain uncontested through entry of the final decree. If the matter becomes contested, this event authorizes us to withdraw from this matter as counsel for you in any legal proceeding and to terminate our representation of you unless we and you have agreed on new terms. Please be aware that if this case becomes contested, the sum paid is non-refundable. The determination that your case has become contested will occur at the time either party requests any assistance from the Court or other counsel.
